## WHAT DOES Atherean Wealth Management, LLC ("AWM") DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. 	When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.	
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons AWM chooses to share; and whether you can limit this sharing.

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
	<ul> <li>Atherean Wealth Management, LLC does not share with our affiliates</li> </ul>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
	Atherean Wealth Management, LLC does not share with non- affiliates so they can market to you
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
